Senator Grassley,

I, along with other whistleblowers, have sent multiple disclosures to you outlining serious CIGIE criminal misconduct with no meaningful action from your staff.

I want an opportunity to meet directly with you (one hour) and bring our whistleblower experts who have spent four years documenting a criminal conspiracy directly involving CIGIE leadership intentionally derailing your efforts to implement procedures focused on good government and accountability.

I believe we can directly assist you and your investigative staff in proposing effective legislation to address legislative infirmities that allow covered members of the CIGIE to avoid criminal accountability with the willing support of fellow CIGIE members from the following organizations: U.S. Special Counsel (OSC); FBI Office of Integrity and Compliance; DOJ Criminal Division, Public Integrity Section (PIN), and the Office of Government Ethics (OGC).

My overall concern is intentional subversion of your efforts to support federal whistleblowers and the total collapse of confidence in the whistleblower safe channel (eg. DoD IG/Overseas Contingency Operations (OCO) currently run by **James R. Ives** of ZDT infamy who has returned to the DoD IG to "clean-up" CIGIE/DoD IG misconduct.

I have a fully credible DoD IG OCO whistleblower who is not willing to come forward until you have restored the DoD IG/OSC whistleblower safe channel.

Federal Whistleblower demand for CIGIE IC records specifically evidencing CIGIE IC refusal to criminally investigate "covered members" of the CIGIE:

- Documented CIGIE IC "Covered Person" abuse of authority in the exercise of official duties (engaging in a scheme/artifice to deprive federal whistleblowers of the right of honest services) in violation of 18 USC §1346
- While under Color of Law, depriving federal whistleblowers of rights secured & protected by the U.S. Constitution in violation of 18 USC §242
- Obstruction of Justice while refusing to conduct legitimate criminal investigation

of CIGIE “Covered Members” claiming that the CIGIE IC Threshold Standard was not satisfied by federal whistleblowers [5 USC §2302(b)(8)(B)/(C) & 5 USC 2320(b)(9)(A)] properly reporting senior criminal misconduct by members of the CIGIE in violation of 18 USC §1505/§1510

- Criminal failure of the CIGIE Integrity Committee (IC) Allegation Review Group (ARG) [5a IG Act §11(d)(5)(i/ii/iii)] to properly receive (register), review, and refer allegations of wrongdoing involving CIGIE “Covered Personnel” in violation of 18 USC §1510 to Attorney General Merrick B. Garland for criminal investigation and/or the U.S. Special Counsel (OSC) Henry J. Kerner for investigation of whistleblower reprisal in the form of Prohibited Personnel Practices taken by “Covered Members” of the CIGIE against federal whistleblowers in violation of 5 USC §1212

- Collaborative inter-agency effort to protect senior agency political officials, by politically appointed members of the CIGIE, designed to avoid enforcement of official oversight actions involving integrity, efficiency, and economy of the Federal government & its programs, activities, and operations in violation of 18 USC §201

- Collaborative inter-agency effort that serves as an **Insider Threat** which appears to be intended to intimidate or coerce members of the civil service (*a civilian population*) designed to subvert the policies of the government (*good governance*) by threatening/intimidating members of the civil service from fulfilling their individual regulatory demand to report senior agency official wrongdoing [5 CFR 2635.101(b)(11)] in direct violation of [18 USC §2331(5)(B)(i)/(ii)]

- Finally, violation of the **CIGIE IC Threshold Standard** by “Covered Personnel” while demonstrating conduct that undermines the independence or integrity reasonably expected by Inspector General (IG) designated CIGIE “Covered Personnel” [5a IG Act §11(d)(4)] charged with protecting the integrity, efficiency, and economy of the Federal government & its programs, activities, and operations in violation of 5 CFR §2635.101(a).
