Enclosed is information evidencing a collaborative inter-agency effort undertaken to obstruct the federal investigative process orchestrated by "covered" members of the Council of the Inspectors General on Integrity and Efficiency (CIGIE):

- U.S. Special Counsel (OSC) **Carolyn N. Lerner**/Associate Special Counsel (ASC) General Law Division (GLD) **Anne M. Wagner** (former MSPB Judge) & Associate Special Counsel (ASC) Investigation & Prosecution Division (IPD) **Louis Lopez**

I must let you know that **James R. Ives**, identified by name in your oversight review of the DoD ZDT Investigation" has returned to the DoD IG as Deputy Inspector General for Overseas Contingency Operations (DIG-OCO) in order to "clean up" OCO misconduct directly involving "Acting" DODIG **Glenn A. Fine** & CIGIE Chairperson **Michael E. Horowitz** (DOJ IG):

- A federal whistleblower with clear & convincing evidence on OCO misconduct involving **Glenn A. Fine/Michael E. Horowitz** is prepared to come forward once assured that the whistleblower safe channel has been restored within DoD IG/OSC

I speak for numerous fellow whistleblowers expressing disappointment in former U.S. Special Counsel (OSC) **Carolyn N. Lerner** (PN805) being nominated as a federal judge on the U.S. Court of Federal Claims for a term of 15 years with a documented record of derailing the OSC investigative/prosecutorial mission in favor of offering "alternative dispute resolution" under the guidance of Associate Special Counsel (ASC) General Law Division (GLD) **Anne M. Wagner** (former MSPB Judge):

- "Alternative Dispute Resolution" assures that agency officials committing prohibited personnel practices are never identified/held accountable for retaliation

An organized 4-year effort by federal whistleblowers to uncover, identify, and document organized malfeasance within the CIGIE Community clearly details efforts to undermine the whistleblower protection process, insult Congress, and betray the American People.
