Halper - one of two informants for Crossfire Hurricane

Father-in-law Ray Klein - had to send soldier of fortune to Mozambique to rescue

Halper who was horrible at his work but did dirty ops for Ray & the CIA.

Halper was stuck there with his wife - Ray Klein's daughter.

Klein created Renamo - acting as a journalist - to evade responsibility for Renamo.

Halper was surrounded by Frelimo - Klein had to send mercenaries to rescue him & his wife. She ended up marrying the soldier who rescued them.

Friends with David Ignatius - CIA rotary.

Halper is Mr Iran-Contra. Founded the Oliver North Defence Fund. Founded the Savings & Loan. Was transporting large quantities of drugs. Archetype CIA bad guy. Pelted for Bush.

But motivated by money more than ideology - switched to Dems because Republicans stopped paying him. Friends with Manafort etc. Will sell anyone out.

Clinton's hired him - paid through Pentagon Office of Net Assessments.

Halper is friends with Lord Malloch Brown & Dearlove. Worried for the govt until Soros paid him more.

Group in Cambridge where they ran all these ops - sometimes govt, sometimes off book,

Dearlove = MI6

Prof Christopher Andrew - MI5

(British FBI - still serving)

Halper - CIA &

All friends with Soros. Soros was getting upset because HRC subpoenaed by Benghazi Comm. Flynn & Trump start talking about the emails.

Knew how to find Steven's from HRC messages - hacked by outsiders - got his location/movements

Have 2 problems - Emails and her health. Soros gets upset.

HRC approaches Cambridge group for help. Halper knows how elections work so he organizes conference in Cambridge in summer 2016

They invite Madeline Albright - she flies over in July 2016.

Conference arranged by CIA guy Steven Schragge who is supposedly just a

student at Cambridge. Friends with Albright & Carter Page. Carter flies over ' they send him to Moscow afterwards - set-up.
Friends with Cofer Black - CIA - (Burisma)

DNC convention around July 26/27
RNC July 19 or so.

Halper coined the term "October surprise". He was the one hanging around airports hoping Carter did not release the hostages. Debate-gate - Halper stole Carter's debate papers. Had to go on the run. Was investigated by Special Counsel etc.

He and Dearlove took out Admiral Stockdale - running as a VP candidate with Ross Perot.

Halper was working for Bush - they connected Perot's campaign with Russia. In truth the Admirak was working with Russia to find US war vets/MIA from Vietnam. Reported by Dealive who was Station Chief for MI6 at the time. Got Dearlove to back them up - same strategy. Same playbook.

Before the convention - had to have strategy in place.

2016: HRC was concerned about losing - losing in the polls, Flynn threatening to find those emails. FBI investigation etc. HRC had to shift the conversation to them - national security risk was Trump-Flynn and not her.

They organize this conference - Albright flies across the Atlantic. meet up with these guys under pretext of conference. Fly Carter Page to Moscow and then to Cambridge.

Halper and Dearlove make speeches at this conference -
Dearlove: Trump is a Nat Sec threat to the UK.

Halper: HRC could lose - 50/50 - so they need to get the media to focus negatively on Trump. Fox the media.

Christopher Steele is a friend of Haloer & Deatlove.

Alexander Diwner also attends and sits next to Steele.

Downer was Australian ambo at the time and also working for:

Hakluyt - semi-private intel shop

Downer and Albright are good friends. Found Downer and Halper at the conference sitting next to Carter Page. Downer is Australian intel - meets

Papandopolous in May but only reports him in July.

Julie Smith - director of Foreign Policy on HRC campaign. Friend/mentor is Albright. Protege of Albright.

Leonard Benardo - VP of Open Society Foundations.

July 11 they decide on the plan at the conference.

July 25 - Leonard writes an email saying it will be a long term affair to demonize Flynn and Trump re Russia - but FBI will pour fuel on the fire later. Say Russia hacked the DNC to help Trump.

Part 1 is Halper & co going to the media.

Part 2 is FBI pouring oil on the fire.

July 27 - Second email saying HRC has approved Julie Smith's idea/plan to distract from her missing emails. In Durham report, they write that Downer goes to the U.S. embassy in London to say DNC emails will be hacked by Russia.

They use that to open Crossfire Hurricane in July 31st. Investigation into Trump campaign - general not specific - info from "friendly foreign govts" - which was a lie. No Five Eyes documents - Devin Nunes tried get it. Did not exist - was all back channel.

At the time Gina Haspel was station chief at the U.S. Embassy in London. Downer goes to Elizabeth Dibble, head of State Dept in London and she takes it to someone who works for Adam Kohler - (legat in London). Kohler becomes Assy Director under Christopher Wray. And later approves the Mar-a-lago raid.

All choreographed.

Have to clear HRC first - July 1st. That was on July 4th. Then Dearlove makes a speech on July 5th at Cambridge, then has the conference and develops the plan.

Deputy Director of MI5 is very close friends with Andrew McCabe. Grassley released text messages. Stayed with his family at his house.

DOJ: Two months before every election there is a blackout - not allowed to investigate anyone. Election interference.

Needed to clear HRC & start investigating Trump campaign before that two-month window.

Needed a pretext to start the investigation on July 30. Schragge said they were targeting Flynn - but because of his stature/clearance it was difficult. So they looked for other people on the Trump campaign-

Downer met with Pap in May and only reported after the conference in July.

Strok then travels to London - Aug 1st.
The they open Crossfire Dragon on Carter Page.

The HRC codename - for email server - shit down kn July 4th. Codename: media exam Grassley just released docs on this.

Crossfire hurricane - movie - Jumpin Jack Flash. Song used by Rolling Stones - movie featuring Whoopi Goldberg. Person communicates with British spy etc.

Published internal notes saying Comey would help Clinton.

Soros emails were circulating & being read - they were worried it would leak so Brennan goes to Obama on

Russia had been reading Soros emails for a long time and the Dutch were reading Russia's emails so Brennan was reading the Dutch intel. He knew that everyone knew.

So they had to act - the morning Brennan gets hold of this he runs to Obama the next - super secret meeting - no notes on this. July 27.

On July 28, Brennan meets with Comey after Obama. Three days later they open Crossfire Hurricane on July 31st.

Aug 3rd meeting with Obama, Brennan, Comey, Sally Yeats etc. Alleged approval from HRC on July 26 to vilify Trump w Russian plan

Obama: Provide any evidence of collaboration between Trump & Russia. Comey responds - four points - all redacted.

Several days later they open with four investigations.
Evidence that Obama ordered the investigation into:

This is the document from internal Soros comms that was in a secret Durham appendix and Svetlana got it released. Took about a year. Remained classified until 2025. Would not let Durham publish it because they said it would compromise sources & methods.

90 percent of the story is a cover-up. This doc ended up in the burn bag. Was in the classified part of the Durham report. Svetlana was screaming - for it to be released. Why? Losing evidence is better than destroying evidence. Did not expect Trump to come back.

Missing pages from Durham report - classified section under Biden 2023. When Trump came in, Svetlana shouting every day on C to get it declassified.

Crowdstrike - CIA front company.

GRU - Russian intel - military

Flynn was working with GRU - setting him up.

FBI 302 & Mueller - always ask about him meeting with Russian military intel.

Steele codename is Crown.

Felix Edmundovich was founder of Russian secret police. Set up Svetlana when they sent her to look for docs on Felix.

Matt Rosenberg: -works for Brennan

1. Had an affair with Flynn
2. Went with him to Moscow
3. Svetlana worked for GRU

A week before the inference at Pembroke, Halper gave a speech outlining the plan because he already knew

Trubnikov - head of Russian intel - close to Cambridge group. Brennan said Putin put him in charge of installing Trump. Was not true. They met with him, were in the same room and then they said whatever they wanted. They used their own source - and made it up. He was retired - did not say anything they said. but they linked the head of Russian intel with Flynn and Svetlana by saying they were all in Cambridge at the same time even though it was different years.

Flynn was developing his own Russian contacts - Clapper was jealous. Did not need Clapper or Brennan or Halper or Dearlove. Said they were worried he was going to be recruited. All of this going on in 2013. When the al Qaeda and ISIS

stuff was going on.

Book from John LeCarre (And Vince Flynn.)

The Spy Who Came in from the Cold. Richard Burton. They lie to him and expose him.

How did they know we would fall in love?

The operation did not depend on it. You just had to be young and pretty & they just needed to get us in the same room.

Already in the files from 2014 - fake report linking Flynn to GRU which they recycled to get rid of Trump.

Feb 28 2014 attended the dinner. Flynn asked if he could stay on while they found a replacement and they said no.

Prof Andrew was very good friends with Clapper.

To get rid of Flynn they organised the investigation and threatened him. Nunes said he saw the report on Flynn in 2014.

Flynn left - went into private sector. The moment he reappears in summer of 2015, all these people reappeared in Svetlana's life at Cambridge.

Nakasoni, head of NSA, Mic Loughlin, head of CIA.

They had all the witnesses saying it was not true - had already been debunked.

Flynn effectively brought Russia-gate with him. Halper knew Republicans are Russian haters.

Flynn was in the way of the Ukraine color revolution - that op was run out of Cambridge.

When Flynn started meeting with Republican candidates in summer/autumn 2015, Dearlove & Clapper etc were asking for lunch/meetings with Svetlana.

Leading Authorities - Flynn's speaking agency was recommended to him by Clapper. They reduced his fee because RT could not afford it. Leading authorities was the one pushing RT. Another set-up.

Stewart replaces Flynn at DIAB- he also comes to see Svetlana at Cambridge.

Taibbi - CIA? Contacted Svetlana in 2018 - was working for Rolling Stone at that point. Wanted to write a story about me. Gen Flynn was going to jail. I told him Halper lied - and why would they invite me to an event with Gen Vincent Stewart the following year if I seduced Flynn at the last dinner in 2014?

He accused me of faking the email -

Grassley specifically released a document saying DIA sent Flynn on a secret mission for DIA to get intel on GRU. Flynn gave them a thumb drive/floppy with the info.

Flynn's brother Jack contacted me - told him the Putin stuff was BS. No one would go to Moscow in December because it is so cold. Had to be on an operation/mission. They renewed his TS SCI clearance in April 2016 so that means he was on an operation. Use retired people with clearances to do backchannel meetings. Later Sen Grassley declassified the DIA briefing with Flynn and Stewart.

Taibbi called me again later - blamed Rolling Stone - then said "let's try again". Contacted four journalists - only one who responded was Rosenberg. He said we are not attacking her - we are attacking Flynn on Brennan's orders. Taibbi says if I do not stop talking, they will publish something really bad about you. Threatening me. Said in emails that Brennan ordered the operation on Flynn. Taibbi trying to reassure me that they were after Flynn and not me.

Matt Rosenberg knew that Halper was not at the dinner.

Published a convoluted story half admitting Halper lied and was not at the dinner. Whole case depends on Halper because he linked Trump to GRU/Russia.

Prof Chris Andrew invites me to dinner with Halper - i contacted Catherine Herridge - was trying to help Flynn who was going to jail. I was talking to journalist from Daily Caller who was investigating Halper. I asked him what do I do, he said call her. She waits a year to get back to me. She had a senior source that said the Halper invitation to have me for dinner is linked to Flynn's trip to Russia.

Prof Andrew was furious that Svetlana would not attend the dinner with Halper. What they do is wear a wire and then they get you to say something and use it to smear you.

Witness for Mueller against Flynn. Were going to threaten Trump with impeachment over this.

Call with Kiseelyak was also a set-up. Obama did the sanctions so that they would reach out.

Peter Diggins - DIA guy suspected of working with Russian intel. Under investigation for ages. Adam Kohler was running the investigation. He came to Cambridge in 2018 and they tried to get him to meet me.

Linda Royer - DIA - also worked in Kosovo. LTC in the army. Also came to Cambridge in 2018 to meet me. Brought Peter Diggins with her. Tried to set me up.

Brennan trying to make up a story in London to justify the investigation - otherwise they manufactured everything. That's why they took away my docs during the raid - without the docs, they could make me guilty by suspicion. Trump first EO declassified the docs again - wants Halper in jail but CIA protecting him.

My lawyer - FBI visited her and told her I am a Russian spy and Trump gave me classified docs.

Halper leads to Brennan and Brennan leads to Obama.

Dearlove was on a podcast with Andy McCabe. How do they know each other? Looking for ways to communicate with each other.

Jeremy Fleming - head of MI5 then becomes head of GCHQ. Close friends with Andy McCabe
